Work was sampled in a range of modules and assessments across levels 4-6.

2. Whether the standards set are appropriate for the award, or award element, by reference to any agreed subject benchmarks, qualifications framework, programme specification or other relevant information.

The standards set continue to appear appropriate.

3. The quality of students' work, their knowledge and skills (both general and subject-specific) in relation to their peers on comparable programmes elsewhere.

The quality of students' work (including general academic skills & subject specific aspects) appeared similar to those in comparable programmes. It was pleasing to see a continuation of very few fails this year – much better than my home institution with a similar programme & student cohort. Again – the programme team are clearly getting things right here.

4. The strengths and weaknesses of the students

I saw a full range of standards of work ranging from fails to 80%s. Strengths and weaknesses appeared similar to the sector as a whole. Students appeared to have engaged well with the subject content, but struggled more with the academic/research requirements. AT L6, Contemporary Issues appeared to prove most challenging with a lower average grade – perhaps thought could be given as to how students might be supported to achieve similarly in this module to other L6 modules into 20/21?

5. The quality of teaching and learning, as indicated by student performance

The sample of work suggests the teaching and learning on the programme is very good. Some students consistently achieved in the 60-70%+ range (with an odd 80%+ also seen). Knowing the team well through my 3 years to date as EE, I have every confidence that teaching and learning is of very good quality.

6. The quality of the curriculum, course materials and learning resources

The quality of the curriculum appears to be effective – particularly with a more relevant L6 route with a specific final year. The course materials and resources I have seen have all been of an excellent standard.

- 7. The quality and fairness of the assessments, in particular their:
  - (i) design and structure

Assessment was through an extensive range of methods including: essays, reports, presentations, practical assessments and reflections, amongst others. Assessment overall appeared fair and very good.

(ii) relation to stated objectives and learning outcomes of the programme

These assessment methods together appear to allow students to meet the objectives and LOs well in a balanced manner.

#### (iii) marking

Marking throughout was very good and appeared to be fair to all students. Feedback points were very detailed (perhaps a little too detailed again?) and moderation was clearly taking place in a thorough manner. The feedback summary, including clear strengths and areas for development continues to be used – an effective strategy for student learning.

8. Where the programme has specific work-related learning outcomes (e.g. Foundation Degrees) please comment on the assessment and achievement of these outcomes, including employers' involvement where relevant.

The L4 Professional Development & L5 Work-Related Learning modules provide students with opportunities to gain experience in one of a wide range of related professional roles, including both a portfolio and assessment of professional practice. However, WRL showed one of the lowest average grades suggesting students possibly have not engaged with this module and/or assessment as well as they could. I am aware of plans being put together to counter the impact of the current Covid-19 situation on work-related modules.

9. The administration of the assessments, operation of examination boards, briefing of external examiners, access of external examiners to essential materials, etc.

Again this has been excellent – my role, as with previous years, has been made very straightforward. Both the LCC programme team and the OU should be commended here.
